To address the impact of lost instructional time, John Adams Academy – Roseville will be continuing the actions in the LCAP that were developed with community input during the 2020-21 school year. The following process was used to develop those actions:

The school considered feedback from stakeholders that has been received throughout the last calendar year when drafting this plan regarding our scholars and their learning loss. An initial list of ideas was drafted by the Executive Cabinet, which addressed stakeholder priorities that has been brought to the attention of the Academy through board meetings, surveys, and meetings throughout the 2020-2021 year. The draft was then discussed with site administration and circulated to teachers and parents, soliciting feedback and any other additional ideas from stakeholders. Feedback received from the stakeholder groups was very much aligned across the Academy. These priorities are reflected in the Local Control and Accountability Plan 2021-24, approved in June 2021. Since August, the school has considered feedback from a variety of groups as well as analyzed data in order to determine any other needs that may have surfaced throughout the first quarter of the school year.

As part of our annual LCAP process, John Adams Academy – Roseville connected with the following stakeholder groups to discuss how the district should prioritize recovery efforts, specifically, in the areas of safe in-person learning, lost instructional time, and other pandemic

impacts. Teachers and staff were asked for feedback in April 2021, and Google docs were filled out so that feedback could be tracked. Google docs were sent out on April 21, 2021. The same feedback forms were made available to the PSO on May 6, 2021. School administrators and Special Education administrators reviewed stakeholder feedback and gave their own in a meeting on June 2, 2021. Finally, students, families, and community members gave input at the LCAP public hearing during the June 17, 2021 meeting of the Board of Directors.

John Adams Academy – Roseville engaged in meaningful consultation with our English Learner Advisory Council on this issue on April 16, 2021 by Zoom meeting. The Academy evaluated its stakeholder engagement opportunities and determined that Civil Rights Groups and Tribes are neither present nor served by the LEA.

The revised ESSER III Expenditure Plan actions are the result of a collaboration between many stakeholder groups, including faculty, administration, parents, scholars, and board members to build a plan that best supports all students in the response to a global pandemic. Keeping school sites open and safe for in-person learning, along with thoughtfully addressing losses in instruction, were at the forefront of all discussions and decisions.

The following outlines input gathered from various groups that impacted this ESSER III Plan:

- Each group identified the need of more Chromebooks to access iReady, Lexia and Independent Study. The Chromebooks would be accompanied by individual headsets for each scholar
- Each group identified the need of an SST Coordinator to address learning loss.
- In order to address the mental health stress for scholars due to Distance Learning, the groups identified the need for Capturing Kids Hearts Training.
- In order to address learning loss for Secondary scholars, it was determined that they needed Reading and Writing intervention.
- There is support for the construction of a permanent outdoor shade structure, for use as a learning pavilion in addition to using for outdoor lunchtime wherein scholars can eat in a safe, ventilated area. This was supported by all community input groups.
- In order to have visual access to curriculum, assist with social distancing and synchronous classroom community building, it was determined to replace projectors with touchscreen monitors.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
