John Adams Academy – Roseville considered feedback from stakeholders that has been received throughout the last calendar year when drafting this plan regarding our scholars and their learning loss. An initial list of ideas was drafted by the Executive Cabinet, which addressed stakeholder priorities that has been brought to the attention of the Academy through board meetings, surveys, and meetings throughout the 2020-2021 year. The draft was then discussed with site administration and circulated to teachers and parents, soliciting feedback and any other additional ideas from stakeholders. Feedback received from the stakeholder groups was very much aligned across the Academy: each group identified summer intervention and intervention aides as the top priority to support scholars' academic success.

The Expanded Learning Opportunity Grant will provide supplemental instruction and support for all scholars within John Adams Academy Roseville. In addition, specific supports will be provided to scholars who are included in one or more of the following groups: low-income, English learners, foster youth, homeless scholars, scholars with disabilities, and scholars who are below grade level, including, but not limited to, those who are credit-deficient scholars, high school scholars at risk of not graduating, and other scholars identified by certificated staff. All services will be part of a multi-tiered system of supports that includes universal (tier 1), targeted (tier 2), and intensive (tier 3) supports or scholars based on their identified needs. Scholars will be identified for additional support with a variety of measures: I-Ready scores, grades, and teacher identification of struggling scholars.

In February, a survey was sent to all parents at the Academy asking if they would be interested in summer learning opportunities for their scholars. Through the development of the summer intervention program, scholars who were identified as needing targeted intervention and/or credit recovery were contacted in the first week of May and invited to participate in the summer program. Beyond summer programming, the Academy will be informing parents of additional opportunities for supplemental instruction and support through the Academy's usual means of communication: ParentSquare, Parent Service Organization (PSO) meetings, board meetings, and the school website.

John Adams Academy Roseville will use the Expanded Learning Opportunity Grant to provide supplemental instruction and support strategies in the following ways:

Extending instructional learning time

- Summer school services for Summer 2021 and Summer 2022
- Interventions provided after school for reading and math

Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports

- Increased staffing of paraprofessionals to provide small group instruction to scholars within the classroom
- Increase hours of paraprofessionals to provide more support throughout the school day
- Educator training on learning strategies, with an emphasis on classical methods to provide engaging learning opportunities
- Expand online program licenses for reading and math intervention

Integrated student supports to address other barriers to learning

- Staffing an MFT supervisor in order to bring in MFT trainees who could assist scholars with social-emotional barriers to learning
- Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility
- Expansion of online licenses to allow for increased credit recovery options
- Additional academic services for students
- Purchase a library of audiobooks so that scholars have increased access to the classics
- Training for school staff on strategies to engage students and families in addressing students' social-emotional health and academic needs
- Educator training on strategies to address scholar needs through leadership and school culture building
 - Staff mentor teachers to train staff on engaging scholars through classical pedagogy

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students’ college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students’ social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
