## **Scholar Chromebook Acceptable Checkout and Use Agreement**

John Adams Academy (JAA) recognizes that technology; specifically chromebooks offers a wide variety of opportunities to further educational goals and objectives to its scholars. Access to the JAA network and Internet through chromebook usage is an educational opportunity requiring responsible use by each scholar. As such, every JAA scholar should act in an ethical and legal manner consistent with the Academy's mission and core values and should conform to educationally appropriate use.

Users of JAA chromebooks and network services should remember that the level of confidentiality on Academy-owned computers may not be the same as that expected when using their own equipment or Internet services.

JAA has taken reasonable steps to ensure that technology services and network use is primarily for activities that support Academy goals and objectives. While the Academy has deployed internet content filtering technology in the interest of keeping harmful and inappropriate content from being accessed, internet content filtering is not a perfect science and it may be possible for users of the internet to access information that is intended for adults. Likewise, computer security cannot be made perfect and it is possible that a determined user can make use of computer recourses for inappropriate purposes.

JAA believes that the benefits of Internet access in the form of information resources and opportunities far exceed the

disadvantages. Ultimately, parent(s) and guardian(s) of minors are responsible for setting and conveying the standards that their child or ward should follow. Use of the academy chromebooks for technology services, network and Internet connections are strictly limited to educational purposes.

**Checkout and Use RESPONSIBILITY as a user of the JAA of chromebooks for technology services, network and Internet connections are as follows, additionally the scholar and parent must agree:**

- 1. Sign and turn in "Chromebook Checkout and Usage Agreement" to JAA**
- 2. Bring your Scholar ID to the computer lab during eligible school period to checkout a chromebook**
- 3. Scholars must be in grades 6-12 to be eligible to check out a chromebook.**
- 4. Chromebook checkout time is the duration of one school period, but can be extended by re-checking it out for additional periods.**
- 5. Scholars must return the chromebook once their duration time is finished to the Computer Technician Specialist in the Computer Lab.**
- 6. Chromebooks must be returned in the shape they were originally when checked out. Fees may apply if damaged or mishandled.**
- 7. "Scholar Technology Acceptable Use Agreement and Internet Safety Policy" MUST BE SIGNED AS WELL.**

Use my chromebook in an acceptable manner, follow all academy rules and regulations regarding network use, including being polite, using appropriate language, and respecting privacy of others.

Use chromebooks efficiently and for educational purposes. Report any known misuse of chromebooks to the appropriate teacher, administrator, or the Academy Office.

JAA supports and respects each family's right to decide to allow for or request the denial of checking out and usage of chromebooks. To allow or deny checking out and usage of chromebooks for your scholar, please check the appropriate box below:
